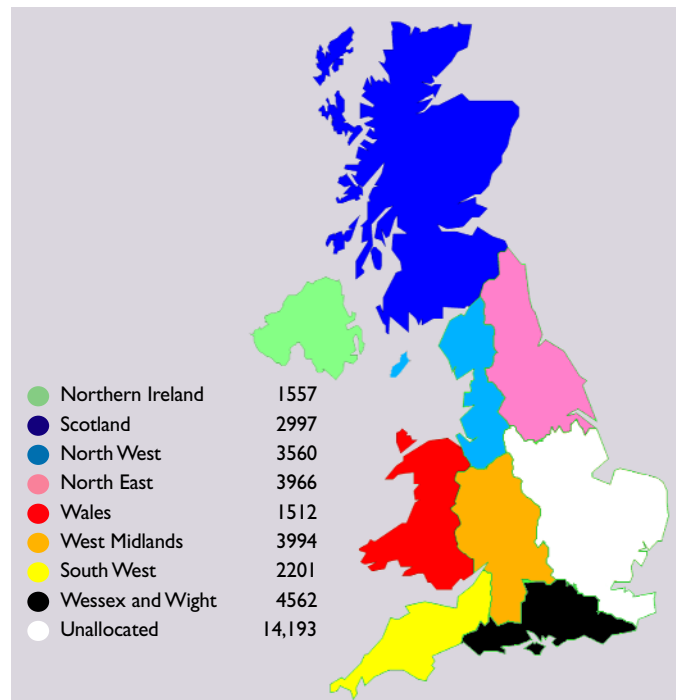

Filling the gaps

ARE you a psychologist living in an area that isn't covered by one of the existing Branches of the Society? Have you ever wanted the same opportunities for CPD that are available to some of your fellow members through their own Branches? Do you ever feel isolated and distanced from other psychologists? Well, we'd like to see the Society's Branches network available to all of our members.

Soon all of you could have the opportunity to take a more active role in your local communities; taking part in special events exclusive to your Branch, which can in turn be used as a vehicle for your own continuing professional development. Several existing Branches organise Branch-specific Divisional events where a number of members from the same geographical area, affiliated with the same Divisions, will get together to discuss relevant local issues. Many Branches also take an active role in local politics, and sharing views and opinions with local MPs. The Society's Branches network offers all members the chance to become part of a local psychological community and brings members together in ways that other Society subsystems cannot.

The Society's Branches Forum has become more active in recent years, and has spent much time reviewing the existing Branches network and the areas of the country that are not covered. Out of a total Society membership in the UK of 38,542, our existing Branches network covers only 24,349 of these; about 37 per cent of members do not have



the opportunity to become a member of a Branch. As you can see from the map, this percentage is made up of a large section of the Midlands and southeast England, including London. The Forum has been particularly keen for

some time to establish a London Branch. The idea is still being developed and, if successful, could be regarded as a potential catalyst for the further development of the network to encompass the whole of the country.

Do you think the expansion of the Branches network is a good idea?

Would you be willing to take an active role in the planning or running of a newly established Branch in your area?

Are you an existing Branch member who believes that you and your fellow Branch members would be able to pass on advice and support to new Branches?

We would like to hear from you – whether you are a member from an area that is not yet covered by the network, or a member with Branch experience who is willing to help with the supporting of any new Branches. SELECTED NEWS FROM THE BOARDS

Board of Trustees (14 January 2005)

- *Branches.* Branches Forum had accepted the proposed solution regarding Branch subventions for 2005 in that Branches use some of their reserves to contribute to their subventions to fund activities in 2005.
- *Honorary Treasurer.* As a result of interviews, Professor Ken Brown is to be recommended as Honorary Treasurer to the Annual General Meeting.
- *Chair of the Research Board.* Professor Martin Conway is to be recommended as the next chair of the Research Board 2006–2009.
- *Board membership.* The chairs of boards are to ensure that vacancies for ordinary members of the boards are filled via co-options. The timing of the 'Call for Nominations for Ordinary Members of the Boards' would be changed so as to avoid December holidays.
- *Educational psychologists.* A letter had been sent over the President's name to the Ruth Kelly, Secretary of State for Education and Skills to request an urgent meeting to discuss short-term arrangements to ensure the continuing supply of qualified educational psychologists, pending the completion of work on the new entry training route for the profession.
- *Charity Commission.* New guidance on paying Trustees had been issued from the Charity Commission and would be considered at the next meeting.
- *Conduct committee.* Decisions will be published on the website, and over time the site will include all decisions made since the Society began to hold open hearings in 2000. The Investigatory Committee and Ethics Committee will be identifying themes for 'Ethics Columns' with the view to the first column being published in the April issue of *The Psychologist*.
- *Statutory regulation.* A risk analysis of the impact on staff will be considered by the Risk Audit and Management Committee at its next meeting.
- *Subscriptions.* Members will be asked to vote on a proposal to vest the Trustees with the power to increase member subscriptions.
- *Publications and communications.* A review report on the work of the Publications and Communications Board and Directorate was accepted. Similar reports are to be produced for all of the boards and will be used for Trustee and new chairs of boards induction.

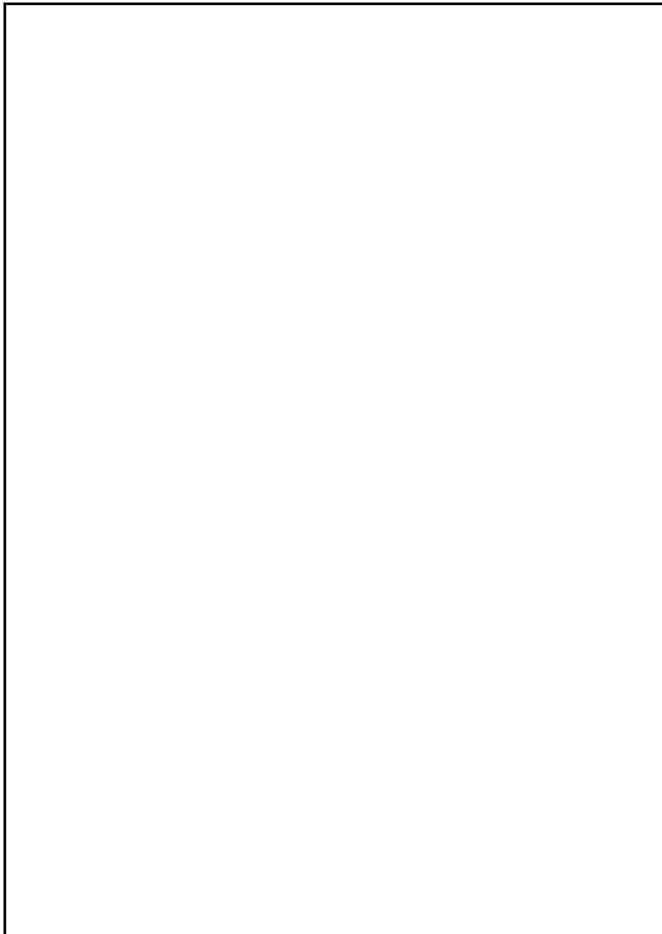
